

## IMPORTANT: Enrollment in FMPH Courses for Spring 2023

Dear Current and Prospective Public Health Majors:

### **PLEASE, PLEASE, PLEASE READ THIS ENTIRE EMAIL!!!**

We realize that this is a long email, but it is extremely important. It contains instructions that are critical to registering for Spring 2023 FMPH classes.

Second Registration for Spring 2023 begins on February 27th. Due to high demand for our courses, **you will need to follow the instructions listed below.**

*It is **VERY IMPORTANT** that you check your [VAC](#) and UCSD email regularly. The program will be sending out time-sensitive updates. If you miss these updates, you may end up not getting seats in classes you need.*

### **INSTRUCTIONS:**

Please check out our [Advising Calendar](#) for up-to-date advising availability. If you are unable to come in during drop-in advising hours or group advising hours, please send any questions you have through the [VAC](#). **Queries received via phone or email will not receive a response.**

### **NOTE REGARDING ALL FMPH COURSES:**

**If you are interested in enrolling in a FMPH course that is full during your first pass, you should waitlist at the very beginning of second pass (students can't waitlist for courses in first pass).** The campus waitlist will be prioritized, and the program will keep an internal waitlist for any impacted FMPH courses. All remaining seats will be filled using the internal waitlist, so please make sure to waitlist at the very beginning of second registration and wait for our [VAC](#) message before switching your schedule. We will message all waitlisted students to let them know if we have seats for them or if we have placed them on our internal waitlist for the course within 2 weeks after **second** registration has started. All students who were authorized to enroll in a FMPH course MUST enroll by the listed date for priority enrollment.

### **IN-PERSON VERSUS REMOTE FMPH INSTRUCTION:**

All FMPH courses will be in-person for Spring 2023, we will not be offering any remote or asynchronous instruction options. Courses that offer an in-person option will indicate a campus classroom. All remote courses will list **RCLAS** indicating the course will be taught remotely.

### FMPH COURSE DETAILS & INFORMATION

#### **FMPH 40: Tuesday/Thursday 5-6:20pm with Dr. Trinidad**

- Prerequisites: none. Open to FR, SO, JR standing. Students with SR Standing must submit an [Enrollment Authorization System \(EASy\)](#) to enroll.

All seats have been released. All other students interested in enrolling in FMPH 40 should waitlist at the very beginning of second registration.

#### **FMPH 101: Tuesday/Thursday 11-12:20pm with Dr. Tan**

- Prerequisites: FMPH 40, PSYC 60 or MATH 11 or COGS 14B or HDS 60. Open to JR, SR standing. Students with SO Standing must submit an [Enrollment Authorization System \(EASy\)](#) to enroll.

All seats have been released. All other students interested in enrolling in FMPH 101 should waitlist at the very beginning of second registration. If you are planning on graduating in SP24 through WI25 you MUST minimally complete either FMPH 101 or FMPH 102 by the end of spring quarter to not prolong graduation. If you have problems getting into at least one of these courses during your first registration, please send the program a VAC message ASAP to let us know.

#### **FMPH 102: Monday/Wednesday 3:30-4:50pm + lab Friday 2-2:50pm and 5-6:20pm + lab Friday 12-12:50pm with Dr. Rana**

- Prerequisites: FMPH 40, PSYC 60 or MATH 11 or COGS 14B or HDS 60. Open to JR, SR standing. Students with SO Standing must submit an [Enrollment Authorization System \(EASy\)](#) to enroll.

All seats have been released. All other students interested in enrolling in FMPH 102 should waitlist at the very beginning of second registration. If you are planning on graduating in SP24 through WI25 you MUST minimally complete either FMPH 101 or FMPH 102 by the end of spring quarter to not prolong graduation. If you have problems getting into at least one of these courses during your first registration, please send the program a VAC message ASAP to let us know.

#### **FMPH 110: Monday/Wednesday 11-12:20pm with Dr. Campbell**

- Prerequisites: FMPH 40. Open to SO, JR, SR standing.

All seats have been released. All other students interested in enrolling in FMPH 110 should waitlist at the very beginning of second registration. If you are planning on graduating in SP24 through WI25 you should complete FMPH 110 by the end of spring quarter to not prolong graduation. If you have problems getting into the course during your first registration, please send the program a VAC message ASAP to let us know.

#### **FMPH 120: Tuesday/Thursday 11-12:20pm with Dr. Nguyen**

- Prerequisites: FMPH 40. Open to JR, SR standing. Students with SO Standing must submit an [Enrollment Authorization System \(EASy\)](#) to enroll.

All seats have been released. All other students interested in enrolling in FMPH 120 should waitlist at the very beginning of second registration.

#### **FMPH 130: Tuesday/Thursday 12:30-1:50pm with Dr. Ciborowski**

- Prerequisites: FMPH 40, FMPH 101. Open to JR, SR standing.

All seats have been released. All other students interested in enrolling in FMPH 130 should waitlist at the very beginning of second registration.

## IMPORTANT: Enrollment in FMPH Courses for Spring 2023

### **FMPH 155: Tuesday/Thursday 2-3:20pm with Dr. Fielding-Miller**

- Prerequisites: FMPH 40. Open to SO, JR, SR standing.

All seats have been released. There are still seats available for second pass, once filled all other students interested in enrolling in FMPH 155 should waitlist at the very beginning of second registration. As a reminder, one FMPH UDE is required for all Public Health majors.

### **FMPH 161: Tuesday/Thursday 8-9:20am with Dr. Zoumas**

- Prerequisites: FMPH 40. Open to SO, JR, SR standing.

All seats have been released. All other students interested in enrolling in FMPH 161 should waitlist at the very beginning of second registration. As a reminder, one FMPH UDE is required for all Public Health majors.

### **FMPH 191 "Racism as a Public Health Crisis": (A00) Tuesday/Thursday 3:30-4:50pm with Dr. Harrell**

- Prerequisites: FMPH 40 & Department Approval to Enroll. Open to SO, JR, SR standing. – Please submit your preauthorization request via the [Preauthorization System](#) for approval to enroll for spring quarter registration. The broad topic of this course is the declaration by multiple municipalities around the country formally declaring racism as a public health crisis. The course will address questions such as: What is structural racism? What is public health? Why are there disparities in health outcomes between races? What are the moral questions raised by the effects of racism on health? What are the moral obligations of medical health and public health professionals? The goal of this course is two-fold: to introduce the main issues and to practice argumentative writing about the moral issues raised by these declarations. NOTE: A minimum of one FMPH UDE is required for all Public Health majors.

### **FMPH 191 " Digital Consumer Health": (B00) Monday 10-12:50pm with Dr. Eikey**

- Prerequisites: FMPH 40 & Department Approval to Enroll. Open to SO, JR, SR standing. – Please submit your preauthorization request via the [Preauthorization System](#) for approval to enroll for spring quarter registration. This course aims to empower students to build a lens to critically evaluate digital consumer technologies used in the context of health, such as self-tracking devices, telehealth, social media, and online communities, by exploring the contexts in which they are designed and used, including their social, cultural, and political underpinnings. While there is much potential for technologies to improve individuals' health and well-being as well as promote population health, technologies can also trigger or exacerbate harms. This course will help to balance positive views of digital health with critical analyses through the investigation of digital health's unintended consequences and the ways it can reinforce marginalization. Students will be encouraged to use systems-thinking and carefully consider context when assessing various digital tools. Thus, through this course, students will learn how to evaluate digital consumer tools that are and can be used by the public to promote health. This is important because consumer technologies are increasingly being used by Public Health professionals as interventions, for health promotion, to monitor and surveil health and disease, and more. Examples throughout the textbook will range across Public Health topics; however, activities will focus on one area, mental health, to build continuity across the course. This course is mostly in the US context but brings in ideas from other countries. NOTE: A minimum of one FMPH UDE is required for all Public Health majors.

## IMPORTANT: Enrollment in FMPH Courses for Spring 2023

### FMPH 194 (Public Health Capstone II)

This class is only for students currently enrolled in FMPH 193. All enrolled FMPH 193 students will be cleared to enroll in FMPH 194 on **March 6th** (after second pass has begun) for the same day/time section and instructor. The final exam for all Capstone courses will be on Saturday, June 10th from 11:30-2:30pm and attendance is required for all students. Enrollment in FMPH 194 requires completion of FMPH 40, FMPH 50, FMPH 101, FMPH 102, FMPH 110, FMPH 120, and FMPH 193 with a C- or higher. Additionally, students must be passing FMPH 193 in order to be cleared to enroll in FMPH 194 on March 6th. All students should be attending capstone lectures regularly and completing course assignments/projects/exams by the listed deadlines on the course syllabus and CANVAS. The program will be checking in with Capstone instructors next week. Any student who has missed over the max allowed absences and/or is in risk of not passing the course with a C- or higher will not be cleared to enroll on March 6th.

### FINAL ITEMS:

As a friendly reminder, you MUST waitlist for any full FMPH courses if you wish to be prioritized by the program's internal waitlist. As stated above, we will message all waitlisted students to let them know if we have seats for them or if we have placed them on our internal waitlist for the course within 2 weeks after second registration has started. Please help us help you by following all FMPH enrollment instructions.

Lastly, we recognize that our advising hours will be limited prior to Spring enrollment. However, we will also be available on the [VAC](#) to answer questions. Please contact us ASAP with any registration questions you may have to ensure that your questions are answered in time for registration.
